



**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE UNIVERSITY OF BENGKULU,
BENGKULU, INDONESIA
AND
NANJING FORESTRY UNIVERSITY,
JIANGSU, CHINA**



The University of Bengkulu-Indonesia and Nanjing Forestry University-China, wish to develop an academic exchange and cooperation program in education and research and both parties concur with the following items:

1. Based on the principles of mutual benefit and respect for each other's independence, the two institutions will foster :
 - a. Students, academic and administrative staff exchange
 - b. Join research activities and academic publications
 - c. Academic material exchange
 - d. Collaborative promotion of other academic activities
2. In order to carry out the above – mentioned activities, a specific written agreement may be agreed to upon negotiation between the two institutions.
3. It is implicit that every activity undertaken under this agreement is approved by the appropriate officials at each institution, and must fall within each institution's academic and fiscal constraints.
4. If matters arise that may be of interest to either Institution, a contact person designated by each Institution is to be informed. That person should develop an effective working relationship with the other Institution.
5. If the contact person changes in either institution, there should be a handover process so that the new person can quickly settle into the role.
6. All intellectual property brought to the relationship by each Institution will remain vested in that institution.
7. Should either Institution contribute resources that are not related to a specific project the other must acknowledge their ownership and their contribution.


8. Use of logos or other institution identification must be agreed by each Institution on a case by case basis.
9. This agreement shall be effective on and after the date of its signing by the authorized representatives of the two institutions, and shall remain in force for the length of 5 (five) years until either institution wishes to terminate. In order to terminate, one year written notice must be issued.
10. This agreement may be modified at any time after negotiation between the two institutions.
11. The Parties wish to conduct their relationship on the basis of good faith and respect for each other's views.
12. Any dispute concerning the subject matter of this document will be settled by full and frank discussion and negotiation between the Parties. Should the dispute not be resolved satisfactorily by these means, the Parties agree that they will engage in mediation conducted in accordance with the terms of the all applicable laws including, but not limited to, non-discrimination and disability law in the performance of this agreement.
